<u>Minutes of meeting</u> held on Thursday 18th May 2023 had been circulated and were confirmed and signed by the Chairman. Annual Meeting of the 18th May had also been circulated for accuracy. 276/2023

277/2023 Andrea Blayney from Llais Cymru had offered to join the meeting to give a short presentation on the re-branding of the Community Health Council to Llais Cymru – unfortunately due to a poor signal we were unable to launch the zoom platform.

Matters arising from meeting of 18th May 2023

278/2023 (233/2023) Updated price received for the sign for the Carpark at Arddleen to include the Welsh translation. It was agreed to proceed with one sign. Highways Dept have confirmed there will be no other signage as warning 'children' signs already exist. Harrisons' have sent a Draft Contract – Councillros agreed that this would not be signed until Powys County Council have approved the Car park once completed. Developers have also sent Pre-application details for the erection of 14 dwellings as Phase II of the development on this site. Resident had contacted Cllr Lucy asking for a Public Meeting to discuss this development – it was agreed that a public meeting would be organized and advertised via the School and the Website

279/2023 (234/2023) Clerk emailed Chief executive NRW to complain of the delays in progressing work at the Wern, Guilsfield – Reply now received explaining that they are looking at evidence to back up the modelling based on the gauge boards and other data. They emphasized that any work needed on the Canal and culverts is the responsibility of the Canal & River trust. Clerk to reply that NRW have a duty to ask CRT to make the necessary repairs. Clrl M Budden agreed to ask Mr R Gunstone if he would be prepared to monitor and record the levels on the gauge by his property.

280/2023 (235/2023) The upgraded Website is now live – many thanks to Cllr Leigh who has also worked on the website to add extra pages. Cllr B C Foulkes has started on a basic facebook Page and asked for Cllr M Budden to help him develop it further.

281/2023 (236/2023) Update: wayleave on Llandrinio Playing Field – it is hoped that all the necessary documentation will be ready next week and it was agreed that the Chairman plus any of the Councillors who are available would go into Harrison's to sign the necessary documents.

285/2023 Cllr Lucy had attended the Environment and Nature Event which took place on Wed 14th June. Whilst action by Community Council's is limited due to to whether they manage any land or not there is still scope to advise re: cutting of cemeteries and Playing Fields.

Recreational Routes

287/2023 Cllr A A White explained that the work on the Footpaths as part of the Levelling up Fund given to connect Communities to the Canal has been successful in opening an additional 3 miles of Footpaths and Bridleways. This had involved 111 kissing gates, 2 equestrian gates, 3 bridges and one board walk and 2 filed gates with a pedestrian gate. Cost of the materials is £40,000+ but would not have been possible without a team of volunteers. Complaint had been received that the Bridleway at Deep Cutting has been signposted but only extends 150m – Alec is in discussion with the Footpath Officer to see if any additional signage is needed.
